- 171 Public Question & Answer:** There were none.
- 172 Planning:**
a.N.Gillard/R.Upton and G. Berry of Berry Associates attended the meeting to propose changes to the plans that had previously been approved for the Gillards Transport site. After an update on the proposed changes, a discussion followed. G.Berry stated that they would be ready to put the proposals to a public meeting possibly in March. **N.Gillard/R.Upton and G.Berry left the meeting. The meeting followed the rest of the Agenda.**
