1489. Finance: a. Update on Finance: The Clerk informed the meeting there is £15,294.99 in the Business Savings Account. £841.01 in the Community Account. £437.78 in The Coach House Account. **b. Parish Clerk's Salary.** The Clerk's presented her May's Salary. SK approved, SW seconded.

c. Parish Clerk's Expenses: The Clerk presented her expenses for £57.49 which included £38.56 beverages for the APM. SK proposed and SW seconded. **d. Gardener's Invoice:** An invoice was not submitted.

e. APM Buffet: An invoice for £300 has been submitted prior to the meeting to ensure prompt payment.

f. Invoice Signage: An invoice for £606.85 was authorised prior to the meeting to enable the order for signage to be placed.

g. Notice Board: The insurance Company approved the payment for a replacement Notice Board and the order was placed prior to the meeting. £672.00

h. Auditors Renumeration: 2 bottles of wine was approved for payment to the Internal Auditor.
